2. What Data We Collect

We may collect the following types of personal data:

Personal Identification Information

- Name
- Age
- Gender
- Email address

Health Information (Special Category Data)

- Medical history and diagnoses
- Current medication and symptoms

- Lifestyle information (sleep, activity, stress, etc.)
- Food intake logs or dietary preferences
- Lab test results (only if provided by the user)

Technical & Usage Data

- Device type, browser, IP address
- · Pages visited, time on site
- Cookies (see Section 8)

3. How and Why We Use Your Data

We process your data to:

- Provide personalized lifestyle advice and medical insights
- Analyze patterns and improve our services
- Communicate with you (e.g., onboarding, newsletters, reminders)
- Maintain platform security and prevent misuse
- Comply with legal obligations

We only process your sensitive health data with your **explicit consent**, as required by Article 9 of the GDPR.

4. Lawful Basis for Processing

We process your data based on:

- **Consent** (Art. 6.1.a / 9.2.a): You provide clear consent for us to process your health and lifestyle data.
- **Legitimate interest** (Art. 6.1.f): For service improvement and analytics, where it does not override your rights.
- **Legal obligation** (Art. 6.1.c): Where required by law (e.g. bookkeeping, complaints).

5. Data Retention

We retain your data only as long as necessary to fulfill the purposes outlined in this policy.

You may request deletion of your data at any time by contacting us at evidencemeetseveryday@gmail.com.

Default retention period: **2 years** after last interaction, unless legally required to retain longer.

6. Your Rights Under GDPR

You have the right to:

- Access your data
- Rectify inaccurate data
- Request erasure ("right to be forgotten")
- · Restrict or object to processing
- Withdraw consent at any time
- Data portability
